**Name of work: Tender for hiring of 1 No. AC taxi car, Model: Etios/Swift D'zire**  
**(Indigo/Ford Fiesta/Verito Models not required)**

The taxi cars should be operated from 06.00 to 20.00 hrs. on all working days. If required, the car should be made available for operation before and after the above timings and also on Sundays and holidays as per the instruction of officer-in-charge.

**General Terms and Conditions:-**

1. The following details of rate for operating the car should be clearly specified.
  - a. Lump sum rate for operating the car from 06.00 to 20.00 hrs. on all working days for a distance of 3000 Km./month is to be quoted. If the total running Km./month is less than 3000 Kms., the remaining Kms., will be carried over to coming months in a block of 6 months.
  - b. The rate per additional Km. above the fixed distance of 18000 Kms. during six months block period should also be specified.
2. The rate quoted should include cost of fuel, oil, maintenance, drivers' salary, insurance, tax, waiting charges and all other incidental expenses, if any, connected with operation of the car. No extra payment will be made by TTPL in addition to the above rate under any conditions.
3. A proportionate change in the rate will be made according to the increase/decrease of fuel price as per the formula prevailing in TTPL.
