5. **Period of contract:** The work should be completed within **Forty Five Days** from the date of issue of Work Order.
6. **The tenderer should have valid ESI and PF registrations and MSME registration if applicable for participating in this tender.**
7. **Pre-Qualification Criteria:** Experience of having successfully completed similar works as per the scope of work like painting of buildings during last seven years ending 30<sup>th</sup> September 2021 should be either one of the following:
  - I. Three similar completed works costing not less than the amount equal to Rs. 1,63,940/- in each work in a single year.
  - ii. Two similar completed works costing not less than the amount equal to Rs.2,04,920/- in each work in a single year.
  - iii. One similar completed works costing not less than the amount equal to Rs.3,27,870/- in a single year.
8. In support of Clause 7, tenderer should submit the **copy of work orders along with satisfactory completion certificates.**
9. The tenderer should remit the Earnest Money Deposit (EMD) mentioned in this document in DD / through company cash counter and proof of thereof should be enclosed along with the tender. Other mode of remittance will not be accepted.
10. Tenders without remitting EMD and Tender cost will be rejected.
11. Work should be done as per the direction of Engineer in charge.
12. **Necessary quantities of Cement & Sand will be supplied by the company at free of cost.**
13. **Contractor should stock the necessary quantities of paint (1Ltr/10Sq.M) before starting painting work and the empty paint tins to be handed over to the Civil section after the painting work.**
14. **Paint colour as approved by TTPL.**

15. **The Paint used should be of premium quality and as approved by TTPL.**
16. **Painting should be done after cleaning the surface thoroughly removing all loose pieces, scales, dust, dirt, algae, scapping the grills of windows etc.**
17. **Approved paint brands for interior paint, exterior paint and primer – Asian, Berger or equivalent.**
18. The contractor has to supply as many specialized workers and necessary tools and tackles based on the urgency of work as mentioned by Engineer-in-charge and the work has to be completed within the time limit.
19. The company is no way responsible for any loss or damage to the materials entered in TTPL campus by the contractor.
20. Lump sum quantities considered in the estimate are approximate and no extra claim is permissible.
21. All the balance materials should be removed and cleared the work site at the end of every day. The work site must be cleaned before submitting the bill.
22. TTPL reserves the right to accept / reject any of the tender after evaluation with or without assigning reason no matter whether a tenderer has quoted the lowest rate. All questions/disputes arising out of or in connection with this shall be decided by the Managing Director of the company and his decision thereof shall be final and binding to all tenderers.
23. Bids should bear the signature of the bidder in all pages.
24. **The rate quoted shall be exclusive of GST and the % of GST applicable should be mentioned at the space provided in the price pro forma. If the bidder is below the threshold limit of GST act that should be clearly mentioned at the space provided for GST. No subsequent claim will be entertained.**
25. Company reserve the right to accept/reject any of the tender after evaluation with or without assigning reason no matter whether a Tenderer has quoted the lowest rate and also have the right to cancel the Work Order forfeiting Security Deposit if the work is not started within 10 days from the receipt of Work Order and also to terminate the contract at any time if the work is not done with proportionate progress to the satisfaction of the Company officials and in such cases, the company will be at liberty to get the work done in any manner that the Company thinks fits and all losses and damage sustain by the Company in this regard will be recovered from the contractor and his assets. All questions/disputes arising out or in connection with this shall be decided by the Managing Director of the company and his decision thereof shall be final and binding to all tenderers.
26. If any irregularity or fraudulent behavior is noticed on part of the contractor / his agents / representatives or the crew of the vehicle engaged by the contractor for the performance of the contract, the company reserves the right to take all suitable action deemed fit against the contractor and those concerned.
27. The contractor will be responsible for meeting all the requirements of the various labour enactments applicable from time to time and should indemnify and keep indemnified

the company against all losses and damages sustained by the company in this regard at all times.

28. Contractor should comply with all relevant formalities under contract labour (Regulation and Abolition) Act 1971, such as display of rate of wages, date, place and time of payment of wages, date of payment of unpaid wages etc. they should also intimate the time, date and place of disbursement of wages to the supervisory Officer nominated under the above act for certification of payment to contract workers.
29. Crawling boards and double hooked safety belts are to be provided to contract labourers working at roof top and high elevation. Workmen using such equipment alone will be permitted to work at such elevated position. The contractor should strictly adhere to the Safety Rules prevailing in the company failing which penalty are decided will be imposed. It is entirely the contractor's responsibility to provide all safety equipment wherever necessary to their workmen. The Company is in no way responsible for any injury, disability or death of contractor's workmen due to non-compliance of safety regulations.
30. The contractor should fix a display board on the materials of their own kept within the Company premises indicating the names of the contractor and work order No.
31. The Company reserves the right to cancel the work order forfeiting security deposit if the work is not started within 10 days from the date of receipt of work order and also to terminate the contract at any time if the work is not done with proportionate progress to the satisfaction of the company officials and in all such cases the company will be at liberty to get the work done in any manner that the company thinks fits and all losses and damage sustain by the company in this regard will be recovered from contractor and his assets.
32. All workers engaged with the work shall have Police Clearance Certificate (PCC) and other formalities insisted by Security Department of TTPL.
33. Canteen charges will be deducted from the contractors bill as fixed by the canteen authorities.
34. **Payment:** Payment will be made after satisfactory completion of the work with the recommendation of the officer in charge. Contractor shall submit Entry Pass issued from Main Gate along with the bills.
35. **Validity of rates:** The quoted rate must be valid for a period for 90 days from the date of opening of the tender and till the completion of the work if the contract is awarded.
36. **Guarantee:** The tenderer should also provide a guarantee for six months against poor workmanship. 10% of the contract amount will be retained by the company during the guarantee period.
37. **Security Deposit:** The successful Tenderer should remit 3% of the contract value as security Deposit immediately from the date of issue of work order. The SD amount will be released after the successful completion of all contractual obligations. EMD of the successful bidder will be released after remitting SD, if applicable. No interest will be paid for SD. On default of the tenderer to remit the Security Deposit and sign the

Agreement, the EMD withstand forfeited and if any loss or damage is sustained by the company in this regard, the same will also be recovered from him.

38. **Performance Agreement:** The contractor should execute an agreement on stamp paper worth Rs.200/- immediately from the date of remittance of Security Deposit, if the total contract value exceeds Rs.1,00,000/-.
39. If the Contractor fails to remit SD and execute agreement within the stipulated period, Company have the right to cancel the work order awarded to the successful bidder and the work will either be executed by L2 bidder or any other source at the risk and cost of the successful bidder.
40. **Jurisdiction:** Any legal proceeding or suit against the Company arising out of or in connection with the tender shall be filed or instituted in a court having jurisdiction in the city of Thiruvanthapuram, Kerala.
41. **Liquidated damages:** In case of any delay in the execution of the Order beyond the stipulated date of work schedule including any extension permitted in writing, the TTPL reserves right to recover from the contractor a sum equivalent to 0.5% of the total value of the delay for each week of delay and part thereof subject to a maximum of 10% of the total value of the Order. Alternatively, the Company reserves the right to execute the work from elsewhere at the sole risk and cost of the contractor and recover all such extra cost incurred by the company in execution of work by the above procedure.
42. All statutory deductions will be made from the contractor's bill as per rules.
43. Bids without remitting EMD and Tender cost will be rejected.
44. Bids with incorrect tender document/format will be rejected.
45. Conditional tenders will be rejected.
