SCOPE OF WORK: Design and Detailed Engineering service for white end filter press building.

- 1. Foundation for Press Filter.
- 2. Foundation for Belt Conveyor
- 3. Building Design- 16m x 9m, two storied building
- 4. Roofing with monorail with 5 MT capacity- 2 Nos.
- 5. Foundation for 35KL Tank- 2 Nos.

I. MCC Room requirement:

- (i) The MCC room shall have at least 5 meter height
- (ii) The MCC room shall be completely leak proof and shall be covered with bricks/blocks in all the four sides
- (iii) The Approximate weight of MCC panel will be 60 MT.
- (iv) The cable shall be routed from the top of the panel (Top Entry).
- (v) Each Panel shall have at least 1.5 meter and 1 meter clearance at the back and front side respectively
- (vi) The MCC room shall be fitted with 2 Nos. of aluminium fabricated sliding two door windows. One door shall be at least 2.5 meter width & 3 meter height.
- (vii) At least two exit doors shall be provided .The door shall be open towards outside.
- (viii) Two Nos. of for 450mm heavy duty exhaust fans are required. Adequate ventilation hole shall also be provided with air filter to prevent the entry of dust inside the MCC room.
- (ix) Adequate provision for inserts shall be provided at the top side of MCC room for cable supports

II. White End Filter Press Building requirement:

- (i) An MCC Room for Electrical section is to be made available in the ground floor of the Press Filter Building. The detailed requirement for MCC room is attached along with. It may be noted that, the room shall be designed in such a way that the norms and conditions for constructing MCC rooms stipulated by Electrical Inspectorate and other statutory bodies shall be incorporated.
- (ii) The Press Filter is to be made available in the First Floor level of the building. The detailed drawings such as GAD and P & ID of the press filter are attached along with. The load, dimensions and other relevant details are mentioned in the drawings.
- (iii) Foundation for press filter is to be considered in such a way that the legs of the press filter is to be installed in the floor level of the first floor or at a minimum foundation height.
- (iv) Two tanks, one for feed pulp and other for discharge cake processing shall be considered in the ground level. The provision for feed pump and discharge pulp pump is to be considered.
- (v) A provision for drawing the cake discharge after the belt conveyor of press filter is to be considered. The discharge cake from the belt conveyor of the press filter is to be carried to the tank where discharge cake is converted to pulp.
- (vi) Monorails for lifting and transferring the parts of press filter as well as tank agitators and pumps shall be considered.

- (vii) An operating platform around the press filter with a width of at least 1 m all around the press filter is to be considered.
- (viii) Foundation for power pack of the press filter is to be considered accordingly.
- (ix) Provision for road access for transferring the pump and agitator is to be considered.
- (x) A basic layout for discussion purpose is also attached along with. The dimensions in the layout are subjected to vary upon further discussions.
- (xi) Sufficient space for approach road to TDP Plant to be provided in Northern and Western side of building for the hassle free transportation of machines.

GENERAL TERMS & CONDITIONS:-

1. Eligibility & Pre Qualification criteria:

- 1.01 Bidders demonstrating at least five (05) years of experience in designing of Infrastructure projects. Please provide details of the job undertaken with satisfactory certificate from client.
- 1.02 The bidder should be entitled as licensed structural engineer from competent institute of repute (i.e. Government body, Institute of Engineers India)
- 1.03 The Bidder should have participated in at least three projects for State Government / Central Government Companies (to be supported with certificate of completion from respective authority).
- 1.04 The Bidder should have turnover of Rs.20 Lacs/annum. Individual chartered/licensed Engineers or firms are also eligible provided they meet eligibility criteria.

2. Other Conditions

- 2.01 It is no binding on the company to accept the lowest offer. The company reserves the right to cancel/ postpone the tender or to reject any or all tenders without assigning any reason.
- 2.02 Exemption in Tender Form Cost and EMD is as per Govt. rules.
- 2.03 EMD: The Tenderer should remit EMD in cash/DD and proof of thereof should be enclosed along with the tender. Other mode of remittance will not be accepted.
- 2.04 **Completion Period:** The work should be completed within **30 days** from the date of issue of Work Order. The work should be commenced **immediately** from the date of issue of Work Order.
- 2.05 **Security Deposit**: Within 15 days of award of contract, the successful Tenderer shall deposit a sum equivalent to 5% of total contract value towards Security Deposit. This shall be paid in the form of Demand Draft in favour of Travancore Titanium Products Limited payable at Thiruvananthapuram from a Nationalized Bank. The Security Deposit shall be returned after satisfactory completion and acceptance of all works included in this tender unless the same is forfeited by the company for any breach or towards any amount due to the company.
- 2.06 It is entirely the contractor's responsibility to provide all safety equipments wherever necessary to their workmen. The company is in no way responsible for any kind of injury, disability or death of contractor's workmen due to non-compliance of safety regulations.






