- **I.** Scope of work: The scope of work includes:-
- 1. Dismantling of 3 Mechanical valve installed in the steam line of Ejector System in Copperas Recovery plant.
- 2. Dismantling of 2" Gate valve installed in the steam line of Ejection System in Copperas Recovery Plant .
- 3. Conveying newly procured 3" control Valve from General stores to copperas recovery plant, including rigging works.
- 4. Conveying newly procured 2" control valve from General Stores to copperas Recovery plant, including rigging works.
- 5. Fitting and commissioning of 3" and 2" control valves in the steam line of Ejector System in copperas Recovery plant along with necessary instrumentation works.
- 6. Fabrication of 3"and 2" connected lines for accommodating the control valves to the existing lines and equipments in steam line of Ejector system
- 7. Obtaining necessary IBR certification from competent authority.
- 8. Weight of 2" Control Valve & 3" Control Valve (combined)-336 kg
- 9. All the material used shall be IBR certified and as per the guidelines of F& B.

II. GENERAL TERMS AND CONDITIONS OF CONTRACT

Sealed tenders are invited by Travancore Titanium Products Ltd., Thiruvananthapuram from experienced contractor for Replacement of control valves in steam line of ejector system in CRP.

1. Pre-Qualification Criteria:

- a) The bidder should have to submit experience certificate in proof of executed similar type of work within last seven years ending 31.03.2024. tenderer should submit the copy of such work orders along with satisfactory completion certificates are to be submitted
- b) The bidder should be IBR approved contractor
- c) The firm shall be registered with registrar of companies in India, should have valid registration number issued by Income Tax Authorities, shall be enlisted as Engineering / manufacturing/ Supply Firm.
- d) The bidder should have PAN, GST, ESI & PF.
- 2. Price to be quoted: The basic rates (including transportation, loading, unloading etc.,) should be quoted only in the proforma enclosed (Page No.5). The bidder shall quote the basic rate per unit as per the rate schedule mentioned in proforma. GST will be paid separately in addition to the basic price at the prevailing rate. The quoted rate of Contractor must be firm and shall be inclusive of cost of transportation of material to the site.
- 3. The rates quoted by the Contractor shall be firm throughout the Contract period and there shall be no upward revision of the rates quoted by the Contractor for any reasons what so ever. It should be clearly understood that any claims for extra Goods and Service Tax, or any Additional tax, etc., shall not be entertained in any case whatsoever once the tenders are opened.
- 4. The tenderer should remit the Earnest Money Deposit (EMD) mentioned in this document in cash/DD and proof of thereof should be enclosed along with the tender. Other mode of remittance will not be accepted. Exemption in Tender Form Cost and EMD is as per Govt. rules.

5. Security Deposit

Within 15 days of award of contract, the successful tenderer shall deposit a sum equivalent to 5% of total contract value towards Security Deposit. This shall be paid in the form of Demand Draft in

favour of Travancore Titanium Products Limited payable at Thiruvananthapuram from a Nationalized Bank. Security Deposit is also acceptable in the form of a Bank Guarantee as per TTPL

Proforma, which shall be supplied on request. Bank Guarantee from Nationalized bank registered in India alone will be accepted. The Security Deposit shall be returned after satisfactory completion and acceptance of all works included in this tender unless the same is forfeited by the company for any breach or towards any amount due to the company.

The security deposit will not carry any interest and will be refunded after the completion of all contractual obligations including guarantee period. On default of the tenderer to remit the Security Deposit and sign the Agreement, the EMD withstand forfeited and if any loss or damage is sustained by the company in this regard, the same will also be recovered from him.

- **6. Completion Period:** The supply should be completed within **25 Days** from the date of issue of Work Order.
- 7. **Safety Regulations:** The contractor should adhere to all safety rules and regulations specified by the Safety Department of the company. The Company is not responsible for any accident occurs during the execution of work.
- **8.** Liquidated damages: The work should be completed within the time limit stipulated in the work schedule. 0.5% of the contract amount will be levied per week for delay on your part as liquidated damages, subject to a maximum of 10% of the contract value.
- 9. Company reserve the right to accept/reject any of the tender after evaluation with or without assigning reason no matter whether a Tenderer has quoted the lowest rate. All questions/ disputes arising out or in connection with this shall be decided by the Managing Director of the Company and his decision thereof shall be final and binding to all tenderers.
- 10. Payment Terms: Payment will be: After satisfactory completion of the whole work All payments are made, after deducting there from income tax and other amounts as may be deductible or recoverable in terms of the contract or the laws in force. All statutory payments in connection with the employment of the workmen for this work will be borne by the Contractor.
- 11. All the balance materials, unserviceable & unwanted materials should be removed and cleared the work site at the end of every day. Unserviceable materials should be dumped in earmarked yards as per the instructions of the officer in charge. The work site must be cleaned before submitting the bill.
- 12. The Gate in pass copy should be submitted to department during the processing of bills for all the construction materials and tools.
- 13. If any irregularity or fraudulent behavior is noticed on part of the contractor/ his agents/ representatives or the crew of the vehicle engaged by the contractor for the performance of the contract, the company reserves the right to take all suitable action deemed fit against the contractor and those concerned.
- **14.** The Contractor and his crew can avail Company canteen facility by remitting the cost of coupons or the food items at the rate fixed by Canteen Authority from time to time
- 15. Company reserve the right to accept/reject any of the tender after evaluation with or without assigning reason no matter whether a Tenderer has quoted the lowest rate.
