**I .Scope of work**

- Scraping of corroded structural part
  - Application of structural primer (zinc chromate)
  - Application of a second coat of light grey (rubber-based) paint
  - Painting materials will be supplied by TTPL, all other materials including tools and tackles, scaffolding work etc are under contractual scope

**II . GENERAL TERMS AND CONDITIONS OF CONTRACT**

**1. Pre-Qualification Criteria:**

- a) The bidder should have to submit experience certificate in proof of executed similar type of work within last seven years. Tenderer should submit the copy of such work orders along with satisfactory completion certificates are to be submitted
- b) The bidder should have PAN, GST, ESI & PF.

**2. Price to be quoted:** The basic rates (including transportation, loading, unloading etc.,) should be quoted only in the BOQ enclosed (Page No.5). The bidder shall quote the basic rate per unit as per the rate schedule mentioned in BOQ. GST will be paid separately in addition to the basic price at the prevailing rate. The quoted rate of Contractor must be firm and shall be inclusive of cost of transportation of material to the site.

**3.** The rates quoted by the Contractor shall be firm throughout the Contract period and there shall be no upward revision of the rates quoted by the Contractor for any reasons what so ever. It should be clearly understood that any claims for extra Goods and Service Tax, or any Additional tax, etc., shall not be entertained in any case whatsoever once the tenders are opened.

**4.** The tenderer should remit the Earnest Money Deposit (EMD) mentioned in this document in cash/DD and proof of thereof should be enclosed along with the tender. Other mode of remittance will not be accepted. Exemption in Tender Form Cost and EMD is as per Govt. rules.

**5. Security Deposit**

To ensure performance of the contract and due discharge of contractual obligations, the successful Bidder will have to provide security deposit of 5 % of the contract value within 15 days from issue of work order. This Security deposit can be furnished in the form of an Account payee Demand Draft payable to Travancore Titanium Products Ltd, Thiruvananthapuram or Bank Guarantee in the prescribed format provided by TTPL from a Nationalized/Scheduled bank. The Security Deposit shall be released on due performance and satisfactory completion of the Contract in all respect without any interest. The security deposit will be forfeited if the successful Tenderer fails to execute the contract to the full satisfaction of the company leading to any loss/damage to the Company (TTPL).

**6. Completion Period:** The supply should be completed within **30 Days** from the date of issue of Work Order.

7. **Safety Regulations:** The contractor should adhere to all safety rules and regulations specified by the Safety Department of the company. The Company is not responsible for any accident occurs during the execution of work.
8. **Liquidated damages:** The work should be completed within the time limit stipulated in the work schedule. 0.5% of the contract amount will be levied per week for delay on your part as liquidated damages, subject to a maximum of 10% of the contract value.
9. **Payment Terms:** Payment will be: After satisfactory completion of the whole work  
All payments are made, after deducting there from income tax and other amounts as may be deductible or recoverable in terms of the contract or the laws in force. All statutory payments in connection with the employment of the workmen for this work will be borne by the Contractor. The contractor shall produce all necessary documents from the Goods and Service tax department.
10. All the balance materials, unserviceable & unwanted materials should be removed and cleared the work site at the end of every day. Unserviceable materials should be dumped in earmarked yards as per the instructions of the officer in charge. The work site must be cleaned before submitting the bill.
11. The Gate in pass copy should be submitted to department during the processing of bills for all the construction materials and tools.
12. If any irregularity or fraudulent behavior is noticed on part of the contractor/ his agents/ representatives or the crew of the vehicle engaged by the contractor for the performance of the contract, the company reserves the right to take all suitable action deemed fit against the contractor and those concerned.
13. The Contractor and his crew can avail Company canteen facility by remitting the cost of coupons or the food items at the rate fixed by Canteen Authority from time to time
14. It is entirely the contractor's responsibility to provide all safety equipment wherever necessary to their workmen. The Company is in no way responsible for any injury, disability or death of contractor's workmen due to non-compliance of safety regulations.
15. The company is no way responsible for any loss or damage to the materials entered in TTPL campus by the contractor.
16. Company reserve the right to accept/reject any of the tender after evaluation with or without assigning reason no matter whether a Tenderer has quoted the lowest rate. All questions/ disputes arising out or in connection with this shall be decided by the Managing Director of the Company and his decision thereof shall be final and binding to all tenderers.
17. **Jurisdiction:** Any dispute or questions relating to or arising out of the finalization of this tender, if remains, shall be subject to the executive jurisdiction of the courts at Thiruvananthapuram. All statutory deductions will be made from the contractor's bill as per rules.
