1. **Scope of Work:** The Scope of work includes the following

- i) Fabrication and fitting of 8" & 6 MS pipe lines from cooling Tower pump discharge to VEP battery limit area & Hot water from VEP battery limit area to cooling Tower. Approx length of 8"- 36 Mtrs pipe line & 6"-12 Mtrs pipeline including bends and flanges
- ii) Necessary supports and clamping of the pipelines.

2. **Completion Period:**

The period of completion of work is **14 days** from the date of issue of Work Order

**3. Rate to be quoted**

The rate should be quoted only in the Proforma enclosed (Page No.3). The quoted rate of Contractor must be firm and shall be inclusive of cost of transportation of material to the site and labour charges. Taxes and duties will be as per State Government as well as Central Government.

**4. General Terms and Conditions**

- ii) The rate quoted should be firm and fixed till the completion of the work. There will not be enhancement of the amount under any circumstances.
