Sealed tenders are invited from experienced contractors for the work of Consultancy services for obtaining factory permit for implementing modifications in Travancore Titanium Products Limited, Kochuveli, Trivandrum. The work should be carried out as per the specific instructions contained in the scope of work and terms and conditions given below.

1. Scope of Work:-

Conducting field survey, Preparation of drawings as per the Factories Rules, Submission of file and getting permit and plan approval from the Department of Factories and Boilers, including liaising work and Assistance until approval of file for:

- 1. Construction of a Cooling Tower for VES Plant.
- 2. Construction of a Cooling Tower for SAP.
- 3. Installation of a new tank and pumping system for Aqueous Ammonia.
- 4. Implementation of a new PNG metering system and transmission pipelines.

Drawing Preparation:

- 1. The contractor shall prepare the drawings in compliance with the applicable provisions of the Factories Rules.
- 2. The final drawings shall be submitted to TTPL via email in both CAD and PDF formats.

TTPL shall provide:

- 1. Facility Layout Drawing (CAD drawing prepared to scale)
- 2. All government challan, statutory payments pertaining to the permit revision applications from the department of Factories and Boilers are at the scope of TRAVANCORE TITANIUM PRODUCTS LTD.

2. Terms and Conditions

- 1. The duration of work is **60 days** from the date of issue of Work Order.
- 2. Contact Safety Department for the execution of work. The contractor is responsible for supplying the required Personal Protective Equipment (PPE) for personnel and maintaining an adequate stock of stationeries needed to carry out tasks within their assigned duties.
- 3. Ensure that all proprietary data, including safety reports, chemical inventories, and operational processes, remain confidential.

3. Additional Terms and Conditions.

- 1. The payment is made
 - 1. 50% Advance along with work order.
 - 2. 50% after completion of work, with the recommendation of the Officer-in-Charge on successful completion of the work with recommendation of Officer in charge.
- 2. All questions, disputes or difference arising under, out of or in connection with this tender shall be decided by the Managing Director (MD) of the Company and his decision shall be final and binding.
- 3. The Company reserves the right to reject any or all tender or to accept any tender partially or wholly without assigning any reason.
- 4. The work shall be carried out as per the instruction of Officer in charge of TTPL.
- 5. The Contractor will be responsible for meeting all statutory requirements of the various labour enactments enforceable in Kerala from time to time and should indemnify and keep in indemnified against all losses and damages sustained by the Company on this regard at all times.
- 6. The Contractor should strictly adhere to the Safety Rules prevailing in the company failing which penalty as decided will be imposed. The Company is in no way responsible for any injury, disability or death of contractor's workmen due to non-compliance of safety regulations. TTPL will not pay any compensation in this regard. All the PPE's to the employees for the execution of the work is under the scope of contractor
- 7. The workers engaged by the contractor shall wear the ID cards provided from the Main gate Security persons and displayed same while on work.
- 8. **Jurisdiction:** Any dispute or questions relating to or arising out of the finalization of this tender, if remains, shall be subject to the executive jurisdiction of the courts at Thiruvananthapuram.
- 9. Agreement: The liability of contractor/bidder under this contract will commence on the date specified in the letter of Intent/ Work order. The successful bidder shall be required to execute an agreement with TTPL if the contract value is above Rupees One lakh, immediately from the date of issue of work order for carrying out the work according to the terms and conditions of the contract given along with work order. The agreement shall be executed on Rs. 200/-Stamp paper and shall be in the proforma as specified by TTP. The provision contained in tender papers and other documents exchanged between the Bidder and TTP shall form part of the contract. The Earnest Money Deposit is liable to be forfeited in case the contractor fails to execute the Agreement within the stipulated period as mentioned above.
- 10. <u>Security deposit:</u> The successful tenderer shall provide a Security Deposit equal to 5% of the contract value immediately from the date of issue of work order for the due performance of the contract. The Security deposit shall not bear any interest and shall be released only after the successful completion of all contractual obligations.
- 11. <u>Liquidated damages:</u> In case of any delay in the execution of the Order beyond the stipulated date of work schedule including any extension permitted in writing, the TTPL reserves right to recover from the contractor a sum equivalent to 0.5% of the total value of the delay for each week of delay and part thereof subject to a

- maximum of 10% of the total value of the Order. Alternatively, the Company reserves the right to execute the work from elsewhere at the sole risk and cost of the contractor and recover all such extra cost incurred by the company in execution of work by the above procedure.
- 12. Evaluation of Bids: The evaluation of the bids will be based only on the documents submitted
- 13. **Deductions:** All statutory deductions will be made from the contractor's bill as per rules. The Contractor shall remit ESI and PF amount and the proof of remittance shall be furnished whenever company insists.
- 14. If the successful bidder fails to remit SD and execute agreement with the stipulated time, TTP will arrange the work with L2 bidder or with any other source at the risk and cost of the successful bidder if required.
- 15. Bids without signature in all pages of tender document/bids in incorrect tender document or format/bids without EMD and tender cost will be rejected.
- 16. In case of any matters pertaining to this tender document and award of contract, which are not incorporated/specified therein, in such cases guidelines of CVC/Kerala Store Purchase Manual shall be applicable.
- 17. Bids without remitting EMD and tender form fee will be rejected.
- 18. Conditional tenders will not be accepted.
