**I. Scope of work:** The scope of work includes

1. Detailed structural stability analysis of the existing vacuum evaporation plant building at TTPL and issue of Structural stability.
2. Identification of any structural deficiencies or arias needing rectification
3. Preparation of accurate and comprehensive As-Built drawings.
4. Submission of all technical reports and drawings in both soft and hard copies.

**TTPL will provide the following,**

- a) All the existing structural drawings will provide by TTPL
- b) Foundation detailed drawing will be provided by TTPL
- c) Excavation for foundation inspection will be done by TTPL .
- d) Soil report will be provided by TTPL
- e) Scaffolding for structural inspection by TTPL
- f) All equipment load data will provide TTPL .

**III . GENERAL TERMS AND CONDITIONS**

**1. Eligibility & Pre Qualification criteria:**

- a) The bidder should have to submit experience certificate in proof of executed similar type of work within last seven years. Tenderer should submit the copy of such work orders along with satisfactory completion certificates are to be submitted
- b) The bidder should have PAN, GST, ESI & PF.

**2. Price to be quoted:** The basic rates should be quoted only in the price preforma.. GST will be paid separately in addition to the basic price at the prevailing rate.


The rates quoted by the Contractor shall be firm throughout the Contract period and there shall be no upward revision of the rates quoted by the Contractor for any reasons what so ever. It should be clearly understood that any claims for extra Goods and Service Tax, or any Additional tax, etc., shall not be entertained in any case whatsoever once the tenders are opened.

**3. The tenderer should remit the Earnest Money Deposit (EMD) mentioned in this document in cash/ DD and proof of thereof should be enclosed along with the tender. Other mode of remittance will not be accepted. Exemption in Tender Form Cost and EMD is as per Govt. rules.**

4. The bidder shall submit Tender Document duly filled and signed along with the enclosures mentioned in the tender document within the time stipulated in the tender notice. Bids should bear the signature of the bidder in all pages.
5. **Completion Period:** The supply should be completed within **45 Days** from the date of issue of Work Order.
6. **Liquidated damages:** The work should be completed within the time limit stipulated in the work schedule. 0.5% of the contract amount will be levied per week for delay on your part as liquidated damages, subject to a maximum of 10% of the contract value.
7. **Payment Terms:** On completion of Work - 100% of the contract value will be paid after satisfactory completion of the work as certified by the Officer-in-Charge.
8. All statutory deductions such as Income tax, Kerala Constructions workers Welfare funds etc., will be made from the contractors bill as per rule.
9. The Contractor and his crew can avail Company canteen facility by remitting the cost of coupons or the food items at the rate fixed by Canteen Authority from time to time
10. **Safety Regulations:** The contractor should adhere to all safety rules and regulations specified by the Safety Department of the company. It is entirely the contractor's responsibility to provide all safety equipment wherever necessary to their workmen.
