- 5.** Lump sum quantities considered in the estimate are approximate and no extra claim is permissible.
- 6.** The tenderer must have **valid ESI, and P.F, MSME registration** if applicable for participating in the tender.
 - a. If the Bidder is not covered under PF Act, a self Declaration is to be submitted along with the Tender.
 - b. If the bidder is not covered under ESI Act, CAR (Contractors All Risk) Policy for the workers has to be submitted for the entire period of contract, before awarding the contract. Declaration to be submitted along with the Tender.
- 7. Pre Qualification Criteria:** Experience of having successfully completed similar works as per the scope of works like Concrete works / Masonry work / corromastic during last seven years ending 28th February 2025 should be either one of the following:-
 - i.) Three similar completed works costing not less than the amount equal to Rs.1,96,388/- in a year.
 - ii.) Two similar completed works costing not less than the amount equal to Rs.2,45,485/- in a year.
 - iii.) One similar completed work costing not less than the amount equal to Rs.3,92,776/- in a year.

8. In support of this, tenderer should submit the **copy of such work orders along with satisfactory completion certificates.**
9. The contractor has to supply as many specialized workers and necessary tools and tackles based on the urgency of work as mentioned by Engineer-in-charge and the work has to be completed within the time limit.
10. **Necessary quantity of solid block, corromastic and SPL solution will be supplied by the company at free of cost.**
11. **Approved brand of cement-Dalmia, Malabar, Shankar or any other as approved.**
12. **Blue variety 20mm metal should be used for the works.**
13. **The company is no way responsible for any loss or damage to the materials entered in TTPL campus by the contractor**
14. **It is entirely the contractor's responsibility to provide all safety equipments wherever necessary for their workmen. The company is no way responsible for any injury, disability or death of contractor's workmen due to non compliance of safety regulations.**
15. **All the balance materials should be removed and cleared from site as soon as the concerned work is over.**
16. Contractor should execute the work as instructed from civil department based on Urgency.
17. Cutting Gases / Acetylene gas with flash back arresters on cylinders are only permitted for gas cutting works. LPG Cylinders (Domestic and Commercial) will not be permitted.
18. **Payment will be made after satisfactory completion of the work with the recommendation of the officer in-charge.**
19. TTPL reserves the right to accept / reject any of the tender after evaluation with or without assigning reason no matter whether a Tenderer has quoted the lowest rate. All questions/disputes arising out of or in connection with this shall be decided by the Managing Director of the company and his decision thereof shall be final and binding to all tenderers.
20. Bids should bear the signature of the bidder in all pages of tender document and work schedule.
21. Tenders without remitting EMD and Tender cost will be rejected.
22. Conditional Bids shall not be considered.
23. **The rate quoted shall be exclusive of GST and the % of GST applicable should be mentioned at the space provided in the price pro forma. If the bidder is below**

the threshold limit of GST that should be clearly mentioned at the space provided for GST. No subsequent claim will be entertained.

24. It is no binding on the company to accept the lowest offer. The company reserves the right to cancel/postpone the tender or to reject any or all offers without assigning any reason.
25. The tenderer should remit the Earnest Money Deposit (EMD) and Tender Form Cost mentioned in this document by means of DD or can remit cash at TTP's Cash Counter (if the amount is below Rs.10,000/-) and enclose the proof obtained thereof (Cash Receipt) along with the tender. Other modes of remittance will not be accepted. **Remittance of EMD is exempted for PSUs and labour cooperative societies. However, exemption from the tender form cost is not permitted.**
26. If any irregularity or fraudulent behavior is noticed on part of the contractor / his agents / representatives or the crew of the vehicle engaged by the contractor for the performance of the contract, the company reserves the right to take all suitable action deemed fit against the contractor and those concerned.
27. The contractor will be responsible for meeting all the requirements of the various labour enactments applicable from time to time and should indemnify and keep indemnified the company against all losses and damages sustained by the company in this regard at all times.
28. Contractor should comply with all relevant formalities under contract labour (Regulation and Abolition) Act 1971, such as display of rate of wages, date, place and time of payment of wages, date of payment of unpaid wages etc. they should also intimate the time, date and place of disbursement of wages to the supervisory Officer nominated under the above act for certification of payment to contract workers.
29. Crawling boards and double hooked safety belts are to be provided to contract labourers working at roof top and high elevation. Workmen using such equipment alone will be permitted to work at such elevated position. The contractor should strictly adhere to the Safety Rules prevailing in the company failing which penalty are decided will be imposed. It is entirely the contractor's responsibility to provide all safety equipment wherever necessary to their workmen. The Company is in no

way responsible for any injury, disability or death of contractor's workmen due to non-compliance of safety regulations.

30. The contractor should fix a display board on the materials of their own kept within the Company premises indicating the names of the contractor and work order No.
31. The Company reserves the right to cancel the work order forfeiting security deposit if the work is not started within 10 days from the date of receipt of work order and also to terminate the contract at any time if the work is not done with proportionate progress to the satisfaction of the company officials and in all such cases the company will be at liberty to get the work done in in any manner that the company thinks fits and all losses and damage sustain by the company in this regard will be recovered from contractor and his assets.
32. Canteen charges will be deducted from the contractor's bill as per rules.
33. Before starting the work, all the workmen under the contractor must undergo a safety training conducting by the Safety department. A declaration regarding successful completion of the training has to be submitted in HR Department.
34. Use of smart phones is strictly prohibited in company campus. However, in the event of any emergency, base model mobile phone without camera can be used under the prevailing rules and regulations of security department.
35. **Validity of rates:** The quoted rate must be valid for a period for 90 days from the date of opening of the tender and till the completion of the work if the contract is awarded.
36. **Guarantee:** The tenderer should also provide a guarantee for six months against poor workmanship. 10% of the contract amount will be retained by the company during the guarantee period.
37. **Security Deposit:** The successful Tenderer should remit 5% of the contract value as security Deposit immediately from the date of issue of work order. The security deposit will not carry any interest and will be refunded after the completion of all contractual obligations. On default of the tenderer to remit the Security Deposit and sign the Agreement, the EMD withstand forfeited and if any loss or damage is sustained by the company in this regard, the same will also be recovered from him.
38. If the Successful Bidder fails to remit SD and execute agreement within the stipulated period, Company have the right to cancel the work order awarded to the successful bidder and the work will either be executed by L2 bidder or any other source at the risk and cost of the successful bidder, if necessary.

- 39. Agreement:** The contractor should execute an agreement on stamp paper worth Rs.200/- if the contract value is above Rupees One Lakh immediately from the date of remittance of Security Deposit and start work after remitting the SD.
- 40. Jurisdiction:** Any legal proceeding or suit against the Company arising out of or in connection with the tender shall be filed or instituted in a court having jurisdiction in the city of Thiruvananthapuram, Kerala.
- 41. Liquidated damages:** In case of any delay in the execution of the Order beyond the stipulated date of work schedule including any extension permitted in writing, the TTPL reserves right to recover from the contractor a sum equivalent to 0.5% of the total value of the delay for each week of delay and part thereof subject to a maximum of 10% of the total value of the Order. Alternatively, the Company reserves the right to execute the work from elsewhere at the sole risk and cost of the contractor and recover all such extra cost incurred by the company in execution of work by the above procedure.
42. All statutory deductions will be made from the contractor's bill as per rules.
43. All workers engaged with the work shall have Police Clearance Certificate (PCC) and other formalities insisted by Security Department of TTPL.
44. In case of any matters pertaining to this Tender which are not incorporated /specified there in, in such cases guidelines of CVC/Kerala store Purchase Manual shall be applicable.
