## **Tender Notice**

Name of work: "Maintenance of 60 MT Electronic Weigh Bridge".

### **Scope of work:**

As a Part of Renewal work of 60 MT s Electronic Weigh Bridge, the following works to be carried out.

1. Dismantling the existing chequered plate, a total of 54 m2 area, Plate were in bending stage, later cleaned both surfaces of MS plates, straightening the plates done as per required.
2. Removal of the damaged 36mtrs of 450X150mm size ISMB Beam support (side beams), later fabricated the new beams as required for replacing the old damaged beams.
3. Removal of the damaged 72mtrs of 200X100 mm size ISMB Beam support (in side beams), later fabricated the new beams as required for replacing the old damaged beams
4. Removal of the damaged 24mtrs of 250X150 mm size ISMB Beam support (cross beams), later fabricated the new beams as required for replacing the old damaged beams
5. Painting done for MS chequered plates after works and for Beam supports with initially primer (one coat) and Enamel paint (one coat) later.
6. New Cu strips provided as required for earthing process of Bridge.
7. After Fabrication and painting of both plates and beams, the erection of the same done as per standards (Fixing the MS plates on top of Beam Structure's, laying Tar felt on top of beam with surface size nuts & bolts, washers etc.)
8. Cleaning the work area and moving the solid waste to the scrap yard etc.

**Work Completion period – 7 Man days** from date of receipt of work order.

### **1. General Terms and Conditions:**

1. The bidder shall submit Tender document duly filled and signed along with the enclosures mentioned in the tender document within the time stipulated in the tender notice. Bids should bear the signature of the bidder in all pages.
2. The bidder shall remit the tender form cost and EMD as given in the tender document. The bids without remitting tender form cost and EMD will be rejected.
3. The rate quoted shall be exclusive of GST. GST will be paid extra in addition to the basic value at the applicable rate. If the bidder is below the threshold limit of GST that should be mentioned in the price format and a self declaration shall be submitted with the tender.
4. The tender must be firm for a period of three months from the date of opening of the tender or till the tender is decided, whichever is earlier during which period the bidder will not be free to withdraw the tender. Any such withdrawal will entail forfeiture of the Earnest Money Deposit (EMD) and also result in the tenderer being made liable for the losses and damages sustained by the company in rearranging the work.  
NB: Remittance of EMD is exempted for PSUs and Labour Cooperative Societies. However, exemption from the tender form cost is not permitted.
5. It is no binding on the company to accept the lowest offer. The company reserves the right to cancel/postpone the tender or to reject any or all offers without assigning any reason.
6. The tenderer should remit the Earnest Money Deposit (EMD) mentioned in this document in cash/DD and proof of thereof should be enclosed along with the tender. Other mode of remittance will not be accepted.
7. If any irregularity or fraudulent behavior is noticed on part of the contractor / his agents / representatives or the crew of the vehicle engaged by the contractor for the performance of the contract, the company reserves the right to take all suitable action deemed fit against the contractor and those concerned.
8. The Contractor will be responsible for meeting all the requirements of the various labour enactments applicable from time to time and should indemnify and keep indemnified the company against all losses and damages sustained by the company in this regard at all times.
9. The Contractor should comply with all relevant formalities under contract labour (Regulation and Abolition) Act 1971, such as display of rate of wages, date, place and time of payment of wages, date of payment of unpaid wages etc. they should also intimate the time, date and place of disbursement of wages to the supervisory Officer nominated under the above act for certification of payment to contract workers.

10. The Contractor should strictly adhere to the Safety Rules prevailing in the company failing which penalty are decided will be imposed. The Company is in no way responsible for any injury, disability or death of contractor's workmen due to non-compliance of safety regulations.
11. The Company reserves the right to cancel the work order forfeiting security deposit if the work is not started within 15 days from the date of receipt of work order and also to terminate the contract at any time if the work is not done with proportionate progress to the satisfaction of the company officials and in all such cases the company will be at liberty to get the work done in any manner that the company thinks fits and all losses and damage sustain by the company in this regard will be recovered from contractor and his assets.
12. Company reserve the right to accept/reject any of the tender after evaluation with or without assigning reason no matter whether a Tenderer has quoted the lowest rate. All questions/disputes arising out or in connection with this shall be decided by the Managing Director of the company and his decision thereof shall be final and binding to all tenderers.
13. Any dispute or questions relating to or arising out of the finalization of this tender, if remains, shall be subject to the executive jurisdiction of the courts at Thiruvananthapuram.
14. **Liquidated damages:** 0.5% of the contract amount will be levied per week as liquidated damages, subject to a maximum of 10% for delay in completion of the work beyond the stipulated period.
15. **Security Deposit:** The successful tenderer shall provide a Security Deposit equal to 5% of the contract value immediately from the date of issue of work order for the due performance of the contract. The EMD of the successful tenderer shall be adjusted against the Security Deposit. Balance amount, if any, shall be remitted by means of a Demand Draft payable at Thiruvananthapuram. The Security deposit shall not bear any interest and shall be released only after the successful completion of all contractual obligations including the Guarantee Period.
16. **Jurisdiction:** Any legal proceeding or suit against the Company arising out of or in connection with the tender shall be filed or instituted in a court having jurisdiction in the city of Thiruvanthapuram, Kerala.
17. **Agreement:** The liability of contractor/bidder under this contract will commence on the date specified in the letter of Intent/ Work order. The successful bidder shall be required to execute an agreement with TTPL within 15 days of receipt of work order issued by TTPL for carrying out the work according to the terms and conditions of the contract given along with work order. The agreement shall be executed on Rs. 200/-Stamp paper and shall be in the proforma as specified by TTP .The provision contained in tender papers and other documents exchanged between the Bidder and TTP shall form part of the contract. The Earnest Money Deposit is liable to be forfeited in case the contractor fails to execute the Agreement within the stipulated period as mentioned above.
