THIS AGREEMENT made in ----- day of ----- 2023 between Travancore Titanium Products Limited, Kochuveli P.O, Thiruvananthapuram, Kerala, Pin.695021 (*Name& Address of Owner*) (hereinafter called "the Owner") of the one part and -----

WHEREAS the Owner invited bids for the execution of work viz., -----  
-----(*Brief description of work*) and had accepted a bid by the Contractor for the work in the sum of Rs.-----/- (*Rupees* -----  
----- *only*) (hereinafter called "the Contract Price").

AND WHEREAS the contractor has submitted the BG/DD for amount of Rs.....(Rupees .....only) as security deposit for the due performance of this contract.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this agreement, viz.:
  - a. the Tender No. ----- and the Price schedule submitted by the Contractor.
  - b. the Owner's Work Order No. ----- dt. -----
3. In consideration of the payments to be made by the Owner to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Owner to complete the work and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Owner hereby covenants to pay the Contractor in consideration of the execution of the works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

IT IS ALSO AGREED that if the contractor violates any of the terms of contract or fails to perform the contract to the satisfaction of the company officials the company is at full liberty to terminate the contract and the company is at full liberty to get the work done in any manner that the company thinks fit and the contractor will be liable for all the losses and damages that the Company sustains on that account and the Company will have the full right to recover/realize all the losses/damages sustained by the Company from the contractor and or his /its assets.

IT IS AGREED by and between the parties hereto that all the disputes and differences or claims arising out or touching this agreement shall, as far as possible be settled amicably through mutual discussions and failing which the matter shall be referred to sole Arbitrator, from the panel of three Arbitrators appointed by the Managing Director of Travancore Titanium Products Limited. The first (Contractor) shall select one Arbitrator from the panel given by the Managing Director of Travancore Titanium Products Limited. The proceedings shall be govern by the provisions of Arbitration and conciliation Act 2016, with all or any statutory modifications from time to time and the award made in pursuance there of shall be binding on the parties, the venue of the Arbitration shall be at Thiruvananthapuram in the state of Kerala.

THE CONTRACTOR further fully agrees that the Security Deposit and Retention Money of this contract need be released to him only after the company is fully

satisfied that he has successfully completed/fulfilled all his obligations under the contract and that the company is at full liberty to forfeit the security and retention and other amounts, if any, lying with the company in case of violation of the terms and conditions or failure on the part of the contractor in fulfilling performing his obligations under the contract in addition to the right of the company to recover/realize all the losses/damages sustained to the company in that behalf from the contractor and/or his/its assets.
